National Academy of Medical Sciences (India), NAMS was established on 21st April, 1961 with the objective of promoting the growth of medical sciences.

The Academy has been recognized by the Government of India as a Nodal Agency for promoting the Continuing Medical Education for medical and allied health professionals.

NAMS was inaugurated at New Delhi on 19th December 1961 by Pandit Jawaharlal Nehru, the first Prime Minister of India. The first Convocation of the Academy was held on 8th December, 1963 at Vigyan Bhavan, New Delhi and the Convocation Address was delivered by Dr. S. Radhakrishnan, the then President of India.

The Academy was re-named **National Academy of Medical Sciences (India)** on 16th November, 1976 on the recommendations of a Working Group set up by the Govt. of India.






