PGMER-23

- PERMITTED VERSUS RECOGNISED SEATS
 ONCE PERMITTED IT IS RECOGNISED
- One can start PG in all specialties in new UG colleges from 3 rd. year onwards.
- One can apply for increase in seats every year and all increased seats will be automatically considered recognised

PGMER-23

- All rounds of counselling through online mode only. No medical college/institution can admit students themselves.
- Medical colleges will have to enter fees while entering seats in seat matrix.

PGMER-23

- Leave rules for PG students
- Option of MCQ type of questions in summative examination
- Penalty clauses for violation of regulations

DIFFERENCE BETWEEN 'QUALIFICATION' AND 'COURSE'

DIFFERENCE BETWEEN 'QUALIFICATION' AND 'COURSE'

- QUALIFICATION is name of a specialty. Course is a training provided by a medical college/institute for acquiring that qualification.
- In the medical field, at the Undergraduate level MBBS is a qualification. At the post-graduate level, there are 85 qualifications or specialities. For example, MD (General Medicine), MD (Paediatrics), MS (OBG), etc.
- Time to time, there is a need to expand the list of specialities with the development of science, technology, etc.

- 1. List of the Current Qualifications (specialties as per PGMER in vogue)
- 2. List of the categories of Medical qualifications granted by Statutory Body Or Other body in India as per the Schedule to NMC Act, 2019.
- 3. List of qualifications as per Part-I of the Third Schedule of the Indian Medical Council Act, 1956.
- 4. List of qualifications as per Second Schedule and Part –II of the Third Schedule of the Indian Medical Council Act, 1956.

LIST OF QUALIFICATIONS

Post-graduate Broad Speciality Qualifications – 3 years Post-graduate Super Speciality Courses - 3 Years Post-graduate Diploma Courses - 2 Years Post-Doctoral Certificate Courses (PDCC) - 1 year Post-Doctoral Fellowship (PDF) Courses - 2 years Post-graduate Super Speciality Courses - 6 Years

INCLUSION OF NEW MEDICAL QUALIFICATIONS

INCLUSION OF NEW MEDICAL QUALIFICATIONS

- Application for inclusion of new medical qualification to respective board
- Acceptance of an application for a new qualification shall be subject to consideration of necessity by the respective Board.
- A foreign authority can also submit its application to the concerned Board

WITHDRAWAL OF RECOGNITION OF QUALIFICATION

if such qualification is no more relevant;

- Alternative course is available;
- Qualifications from Indian or international bodies, accepted by erstwhile MCI/ NMC without prescription of any standards, if there are alternate courses prescribed with standards, under NMC.

MAINTENANCE OF STANDARD OF MEDICAL EDUCATION REGULATIONS-23(MSMER-23)

MAINTENANCE OF STANDARD OF MEDICAL EDUCATION REGULATIONS-23(MSMER-23)

- Annual disclosure by a college as per conditions of MSR to UGMEB or PGMEB.
- Evaluation of report by UGMEB OR PGMEB
- Assessment
- Remedial measures/ Renewal

SANCTIONS & PENALTY FOR VIOLATION OF REGULATIONS

SANCTIONS & PENALTY FOR VIOLATION OF REGULATIONS

- For non-compliance or intentional attempt of non-compliance act or omission, the PGMEB will penalize the medical college/institution.
 - **o** Issuance of warning with direction
 - Monetary penalty not exceeding INR one crore per violation/act of omission committed by the medical institution;


- monetary penalty not exceeding Rupees five lakhs for the faculty/ Head of the Department (HoD)/ Dean/Director/ Doctor submitting false declaration/documents/records (including patients' records).
- Further, they can also be charged or penalized for misconduct under the Professional Conduct Regulations in vogue.
- Withholding the accreditation process;
- recommending to MARB for withholding processing of application(s) for any new course including increase of seats in the existing course for that academic year or for such number of years.

SANCTIONS & PENALTY FOR VIOLATION OF REGULATION

- Reducing the number of students in the next or subsequent academic years to be admitted by the medical institution;
- Stoppage of admission to one or more of the courses in the next or subsequent academic years.
- Recommending to NMC for withdrawal of permission;
- Withholding and withdrawal of accreditation for a period up to five academic years.

PENALTY FOR VIOLATION OF REGULATION (contd.)

- Any attempt to pressurize PGMEB or NMC through individuals or agency will lead to immediate halt of the processing the application/request by the medical institution.
 - Provided further that the medical institution, may be granted a reasonable opportunity to rectify the deficiencies and any further action shall be taken if it fails to meet the requisite norms.
 - Provided further that, the PGMEB or the NMC may also initiate criminal proceedings for furnishing false information, or fabrication of false documents.
