5. The applications submitted must have **self attested support documents for the** information provided in the application form such as educational qualification, academic, research and administrative experience.
6. **Applications which are incomplete or not according to the prescribed format will not be processed and considered.**
7. **The Fee for the International fellowship is USD 750 and for the International Membership is USD 600 to be paid AFTER SELECTION.**
